At a special meeting of the Town Board of the Town of Alexander in the County of Genesee, New York, held in the Town on the 24th day of May 2022 at 8:30 a.m.

In the Matter of the Proposed Modification of the Town of Alexander Water District No. 6 Pursuant to Section 196 of the Town Law

**ORDER FOR A PUBLIC HEARING
RELATIVE TO THE PROPOSED MODIFICATION OF
TOWN OF ALEXANDER WATER DISTRICT NO. 6
PURSUANT TO SECTION 196 OF TOWN LAW**

WHEREAS, the Town Board of the Town of Alexander formed Alexander Water District No. 6 in accordance Town Law Article 12-A, a Final Order Establishing District having been duly adopted December 14, 2020, a certified copy of which having been recorded in the Genesee County Clerk's Office on October 25, 2021; and

WHEREAS, the Final Order provided that Water District No. 6 was to be constructed at a maximum cost not to exceed \$5,270,000.00; and

WHEREAS, pursuant to Section 196 of Town Law, the Town Board of the Town of Alexander wishes to modify Water District No. 6 based on increases in the pricing of materials due to the COVID-19 pandemic, and concurrently, but distinct and separate, the County of Genesee will undertake a water system project that will benefit the Town of Alexander; and

WHEREAS, the upgrades by the County of Genesee to the Genesee County Water Project include a financial contribution to the Town of Alexander for a 1,600,000 gallon water storage tank and 26,700 linear 8-inch transmission main along Dodgeson, Day, Goodman, and Halstead Roads; and

WHEREAS, the Town Board of the Town of Alexander recognizes that Genesee County is pursuing water improvements, and the Town Board of the Town of Alexander believes it to be in the best interest of the Town of Alexander to separate a portion of the Water District Project which will be completely funded by Genesee County; and

WHEREAS, to simplify the construction, coordination, and reduce costs, the County's project will be completed separately from the Town of Alexander's Water District No. 6 project; and

WHEREAS, the Town of Alexander will cover the costs of the installation of approximately 67,200 linear feet of 8-inch distribution water main along Halstead, Upton, Richley, Pike, Beaver, Wortendyke, Bennet, Dodgeson, Hickox, Seward, Day, Walker, and Sprague Roads; and

WHEREAS, the Town of Alexander will service the Genesee County project within the boundaries of the Town of Alexander in addition to the Town of Alexander Water District No. 6, as the projects are separate and distinct but, interconnected; and

WHEREAS, a revised map, plan and report has been prepared by Mountain Engineering, PLLC dated May 25, 2022, which engineers are duly licensed in the State of New York, and which revised map, plan and report is on file in the office of the Alexander Town Clerk for public inspection; and

WHEREAS, the maximum amount to be expended by the Town of Alexander is \$6,270,000.00; and-

WHEREAS, to the extent necessary, the separate and distinct project to be undertaken by the County of Genesee will be undertaken in conjunction and in cooperation with the Town of Alexander Water District No. 6; and

WHEREAS, the estimated cost of the district to a typical one or two family home in the amount of \$1,189.00 and other one-time costs as depicted in the original map, plan and report shall remain; and

WHEREAS, the total number of Units within Water District No. 6 will remain the same; and

WHEREAS, the Town Board of the Town of Alexander proposes to modify Water District No. 6 and to conduct a hearing with respect to same and to hear all persons interested in the subject thereof and concerning the same in accordance with the provisions of section 196 of the Town Law; and

NOW THEREFORE BE IT:

ORDERED, that the Town Board of the Town of Alexander, New York, shall meet at the Alexander Town Offices, located at 3350 Church Street, Alexander, New York on the 13th day of June 2022, at 8:30 p.m. for the purpose of conducting a public hearing in accordance with Section 196 of Town Law on the proposal to modify the Town of Alexander Water District No. 6 and take such other and further action as may be required and authorized by law; and be it further

ORDERED, that the Town Clerk of the Town of Alexander is hereby authorized and directed to publish a copy of this Order in The Daily News, to post a copy of the same on the signboard of the Town of Alexander not less than ten (10) nor more than twenty (20) days before the day designated herein for said public hearing.
